I, the undersigned student at the Academy of Our Lady of Peace agree to the following:

- I understand that each pass is verified for accuracy and that any forged signatures will result in the forfeiture of dance/event attendance by myself and my escort and that I will be subject to disciplinary action.
- I understand that I must arrive and check into the dance by 8:00 p.m. and may leave no earlier than 10:30 p.m.
- I understand that I will enter and leave the Ball with my escort. I understand that once I leave the dance there is no re-entry.
- I understand that The Miss OLP Ball is a semi-formal dance and AOLP Students are required to wear a tasteful, elegant dress that conforms to AOLP dress guidelines. (Please see Parent Letter). Gentlemen are required to wear a suit or sport coat/sweater with a tie. No tennis shoes are permitted. Any student or escort dressed inappropriately (which is determined at the discretion of the administration) will be denied admission without a refund and released to their parent/guardian.
- I understand that the style of dancing must reflect proper behavior between students. The following types of dancing are considered inappropriate: dancing too closely to one another, dance moves that are sexually provocative (dancing that simulates sexual activity), freaking or dirty dancing, front to back dancing or any dancing which may result in disruption or injury (i.e. slamming, moshing, etc.) I understand that students and their escorts who do not comply with these guidelines may be removed from the dance floor, released to their parent/guardian, and/or receive disciplinary consequences.
- I understand that all school rules apply at school-sponsored events for both myself and my escort, no matter what their age. I am responsible for informing my escort of all AOLP behavior and dress code rules. Violations will result in disciplinary action for myself and removal from the Dance for myself and my escort and release to their parent/guardian.
- I understand that any person removed from the dance is not entitled to a refund.
- I understand that attendance at the Miss OLP Ball is contingent on the acceptance of the security guidelines. (See Security Guidelines on reverse side). With my signature on the Dance Pass, I, my parents and my escort agree to abide by these guidelines and to accept all consequences of non-compliance with the guidelines

SECURITY POLICY

In order to ensure that all students and their escorts who attend the Miss OLP Ball 2010 can enjoy their evening in a safe, drug-free, alcohol-free environment, the Academy of Our Lady of Peace has hired a team of faculty chaperones and hotel security officers to provide security.

The security team will greet each student and escort as they arrive. Each student and escort must show their ID (school, work, DMV) to enter the dance. The security team will circulate throughout the Ball and premises for the remainder of the evening to observe for drug and/or alcohol influence and/or possession, as well as for any other behavior deemed dangerous to the attendees of the Ball, sexually provocative or otherwise patently offensive to the Catholic faith.

The following items are not allowed at the Miss OLP Ball and will be confiscated by the security team: food or drink of any kind, alcohol, drugs or smoking, hats, weapons, and purses bigger than an open hand. Upon request by the security team, students may be asked to show the contents of pockets or purses.

Should any chaperone or member of the security team suspect any persons of drug/alcohol influence/possession at any time on the Ball premises, the Director of Student Services of the Academy of Our Lady of Peace will be alerted immediately. The security team will assist, if necessary, with the removal of said persons to a special area set aside to deal with these problems. If deemed necessary by the school representative, the parents of the Academy of Our Lady of Peace student and/or escorts will be notified, and/or a breathalyzer test will be administered and action will be taken.

In the case of drug/alcohol influence/possession or repeated behavioral problems by an AOLP student or their escorts, both the student and their escort will be removed from the Ball and Ball premises, released to their parent/guardian and are not entitled to a refund.
